**ARTICLE I. IN GENERAL****Sec. 34-1. Police Department manual of standard operating procedures governs.**

The manual entitled "North Judson Police Department Standard Operating Procedures" is hereby adopted and incorporated by reference into this chapter.

The "North Judson Police Department Standard Operating Procedures" manual, in its entirety and in multiple copies, is on file in the Clerk-Treasurer's office for public use and inspection.

**Secs. 34-3—34-22. Reserved.****ARTICLE II. TOWN MARSHAL****Sec. 34-23. Chief Police Officer.**

(a) The Marshal is the Chief Police Officer of the Town and has the powers of other law enforcement officers in executing the orders of the Town Council and enforcing laws.

(b) The Marshal or his deputy:

(1) Shall serve all process directed to him by the Town Council;

(2) Shall arrest without process all persons who commit an offense within his view, take them before a court having jurisdiction, and detain them in custody until the cause of the arrest has been investigated;

(3) Shall suppress breaches of the peace;

(4) May, if necessary, call the power of the Town to his aid;

(5) May execute search warrants and arrest warrants; and

(6) May pursue and jail persons who commit an offense.

**Sec. 34-24. Appointment of Deputy Marshals.**

The Town Council authorizes the Marshal to appoint Deputy Marshals. Deputy Marshals have the powers and liabilities of the Marshal in executing the orders of the Town Council or enforcing laws.

**ARTICLE III. PUBLIC POLICE DONATION FUND**

**Sec. 34-52. Established.**

A fund entitled "Public Police Donation Fund" is hereby established for receipt of any donations to the North Judson Police Department.

**Sec. 34-53. Processed through Clerk-Treasurer.**

All donations shall be made through the Clerk-Treasurer for proper processing and receipt creation.

**Sec. 34-54. Use of fund.**

Such fund shall be used for the sole purpose of Police Department expenditures, including but not limited to equipment, training, etc.

Any expenses from this fund shall be approved in advance by the Town Council.
