**ARTICLE I. IN GENERAL**

It shall be unlawful for any person to dispose of any paper, rubbish, or other garbage in any manner other than placing the material in an approved public or private waste container.

**ARTICLE III. GARBAGE AND RUBBISH**

**Sec. 50-45. Approved receptacles for residential dwellings.**

All garbage and rubbish receptacles shall meet the following specifications:

- (1) They shall be made of sturdy, watertight plastic, rubber, or metal, with two handles or a bail.
  - (2) They shall have a capacity of no more than 50 gallons and a gross weight when filled of no more than 100 pounds.
  - (3) The owner of the receptacle shall keep it in a sanitary condition.
  - (4) They shall have a close fitting cover and be covered at all times.
  - (5) The garbage and rubbish contained therein shall be bagged and not loose.

**Sec. 50-46. Dumps not allowed.**

It shall be unlawful for any person to make a private dump or dump garbage or rubbish on any private or public property within the Town limits.  
(Code 1959, ch. 9, art. III, § 9-9)

**Sec. 50-47. Prohibited items.**

The following items shall not be disposed of as garbage or rubbish:

- (1) Human waste or sewage.
- (2) Animal carcasses.
- (3) Biohazardous medical waste, including but not limited to used syringes, human bodily fluids, and items saturated with any human bodily fluid.
- (4) Paint, motor oil, solvents.



- (5) Explosive material, including but not limited to dynamite, dynamite caps, firearm ammunition, and gasoline.

**Sec. 50-48. Minimum monthly fee.**

A residential customer within the corporate limits of the Town shall be assessed the minimum monthly fee in an amount as established by the town council for trash removal. No credit shall be given for nonuse or for vacant residences, whether it be temporary or on a permanent basis.
