\*No refunds are given for denied applications, so please make sure everything is complete and accurate prior to submitting it for consideration.

Please note: Mr. Radtke does the Building Inspection work for the Town on a part-time basis, but he normally tries to process applications within a few days. If you have a specific question about your application, or you need to speak with him for any reason, feel free to call him at 574-806-6554. He does have a regular full-time job, so you may have to leave a message, but he will return your call as soon as he is available.

Once Mr. Radtke approves your application, he will bring your permit to the Water Department for pick-up. **Please be aware that any contractor you are paying must be registered with the Town prior to beginning your project.** Contractor permit applications are available at [townofnorthjudson.com](http://townofnorthjudson.com) and at the Clerk's Office/Water Dept.

\*Please note: No portion of a swimming pool shall be located at a distance of less than ten (10) feet from ANY side or rear property line or building line, and no less than twenty (20) feet from any existing dwelling unit or abutting property. Pools require fences, BUT the structural sides of the aboveground swimming pool may be used in satisfying a portion of the fence height requirement. Pools 48" or taller do not require fences. Pools 24" – 47" REQUIRE a fence.

**\* All Contractors performing work within the corporate limits of the Town of North Judson MUST be registered with the Clerk-Treasurer and obtain a contractor's permit PRIOR to performing ANY work. Applications can be picked up at the Clerk's Office.**
